RW reported to the PB that the Greater London Authority seed funding for the Disability Network will end in August 2024, but there is an opportunity to apply for more funds. In the meantime, HWK has integrated this work into the All-Ages Learning Disability Partnership Board (AALDPB). This will include a page on the work of the RBK Disability Network in the AALDPB Annual Report 2023-24.

The AALDPB heard from RBK about user research at Kingston Council. Ella Grimmett, RBK User Researcher for Adult Social Care, explained how the council is engaging with residents through interviews, surveys, and usability tests to gain insights into their requirements, usage patterns, and expectations of services. Current RBK research projects include:

- Financial Assessment for Adult Social Care
- Eligibility for Adult Social Care Research
- Website Improvement Review.

# Kingston Mental Health and Wellbeing Group:

During the meeting, held on 30 January 2024, we had an update from RBK about the progress of the Carers' Strategy Implementation.

We also had a short update from RBK that Kingston had committed to becoming more Age Friendly. Kingston has joined over 60 other towns and cities in the UK as part Centre for Better Ageing's UK network of Age Friendly Communities. The focus will be to improve healthy ageing and increase a healthy life expectancy in Kingston. This means starting early to ensure healthy lifestyle and outcomes for people of all ages in Kingston, and how this links to mental health

South West London and St George's NHS Mental Health Trust (SWLStG):  SWLStG is currently delivering a transformation of community mental health services in Kingston. As part of this process, SWLSTG commissioned local Healthwatch to gather feedback and experiences from service users to improve their services and prioritise user-centred care. Phase three of data collection has now completed. The final report that will compare all three phases of data is being drafted and is currently scheduled for publication at the end of April 2024. The Deputy Head has agreed that a few pupils from these three schools will form a project group to support YOL!'s work.

Bereavement film (funded through the RBK Resilience Fund). We have explored a series of dates for us to work with pupils (as part of the film/podcast project group) from the Every Child, Every Day Academy Trust during spring and summer terms to co-design the bereavement film and the podcast about access to NHS and social care services for young people with disabilities.  Our 'YOL! meets' the London Ambulance Service Kingston Cycling Paramedic session was published on www.yolweb.info on Friday 26 January 2024.

We met with YOL! on Tuesday 5 <sup>th</sup> March to discuss being safe while using social media. The meeting provided good insights which included how young people can inadvertently bring pressure to bear on other young people via online messaging by expecting a quick response this can at times escalate from worry to panic - e.g. "Why hasn't Oliver responded to my message about what's on TV tonight, it's been over 15 minutes, I hope he's OK?". Parents are often unaware that posts on social media about their children when younger can cause upset. Also concerns were raised about being mindful to not share personal images without consent.

# 6. Safeguarding

**6a.** Continue membership of the Kingston Safeguarding Adults Board.

Gather service user experience of safeguarding to inform service developments and support positive personal outcomes

SB now represents HWK at the Kingston Safeguarding Adults Board (KSAB) and updates KSAB about the work HWK is doing in relation to the Making Safeguarding Personal (MSP) project and the London Safeguarding Voices (LSV) group (for the London Safeguarding Adults Board).

SB, HJW, and SBa met again with Daniel Morris, the KSAB Manager to discuss our emergent plans for the Kingston Safeguarding Voices (KSV) group. It was agreed at the KSAB Annual Development Day that KSV would become a subgroup of the KSAB - in a move to ensure the voices of people with lived experience is heard at the heart of governance. We continue to liaise with Daniel/RBK about the next steps. SBa has set dates for a series of lunchtime KSV introduction sessions for the end of April 2024.

## **KSAB Communications and Training Sub-group:**

HJW attended the KSAB Communications and Training Sub-group quarterly meeting for the first time, on Tuesday 26<sup>th</sup> March. We discussed raising awareness of safeguarding to Kingston residents and businesses. This is an ongoing priority for the KSAB. HJW stated (and as previously mentioned at the KSAB Development Day), the LSV and LSAB are keen to pull together a conference for National Safeguarding Awareness Week 2024, for residents rather than professionals, using language they would be able to understand, across London boroughs. HJW advised the LSV are



		working with London ADASS to pull together something very basic and would happily work with Kingston on this too.  HJW learned of KSAB Seven Minute Briefings - these are very useful for anyone working within safeguarding and are designed to refresh or update staff on various areas within safeguarding, e.g. Safeguarding Referrals Process, Cuckooing, Domestic Violence and Scams. However, not all of these are currently available on the KSAB website. Some could also be very relevant for non-professionals. HJW will work with Daniel Morris and Sophie Potter (new RBK Corporate Communication and Engagement Manager), to make these more accessible to all.  (Author HJW)

The LSV members are now meeting twice a month to share lived experiences of safeguarding and to participate in the planning and delivery of the LSAB Annual Conference.  London Safeguarding Adults Board Conference: Recordings and presentation slides from all Conference sessions during the LSAB Conference Week 2023 are now available through the HW Kingston website.



Planning Groups to ensure people with lived experience of safeguarding are integral to safeguarding systems and processes across London. Discussions with the LSV members about a half day conference during National Safeguarding Adults Week 2024 continues. This online event will tailor to local residents, with no professional experience of Safeguarding Adults, but would generate a better understanding of what safeguarding adults actually is, the signs to look out for and a better knowledge of referral pathways etc.

#### **Peer Reviews:**

The LSV have been involved in three peer reviews from Jan - March 2024 for Lewisham, Kingston, and Havering. One LSV member attended each face-to-face peer review. A new request for the LSV members was to perform a 'secret shopper' exercise on both the Lewisham and Havering local authority websites. The LSV members were asked to look at how accessible and clear the website is to navigate and how 'fit for purpose' it is if a non-professional is concerned about an adult at risk. Not every local resident will know what 'safeguarding' actually is. This work also feeds nicely into our LSV 'front door access to safeguarding' survey, which the LSV will re-visit from April 2024.

## Met Police Service (MPS) Scrutiny Panel Involvement:

The MPS are reviewing many of their safeguarding procedures, including refreshing the MPS Adult Safeguarding Policy and MPS guidance to recognise vulnerability. The MPS also want to create an Adult Threshold document to assist with decision making as to what should be referred over to Adult Social Care and at what level. Matt Hogg (Detective Chief Inspector, Public Protection Delivery Group - Op Aegis & Dedicated Inspection Team) is leading this review. He has asked the LSV to assist in being part of a sub-group scrutiny panel, made up of interested partners, third sector organisations and those with lived experienced of adult safeguarding/ care and support needs.



	The aim is to be open and transparent around how the MPS deals with, and works with others, to safeguard the vulnerable. To improve trust and confidence in the MPS approach to Adult Safeguarding and to capture organisational learning and feed it back to improve the safeguarding services the MPS deliver.  Healthwatch England (HWE) Safeguarding Workshop - 28th February 2024:  SB and HJW were asked by Andre Benham (Volunteering and London Regional Network Manager, HWE) to run a Safeguarding workshop, for other local Healthwatch (LHW). We talked through our HW Kingston safeguarding work (MSP, LSV and KSV) and then went into smaller groups to discuss the role of LHW in safeguarding, what safeguarding links they have locally, what additional support they would like, and the role of HWE in this.  Andre has now set up a specific HWE safeguarding group in Workplace.  (Author HJW)

Healthwatch Kingston's final Open Meeting for 2023-24 was due to focus on Hospital and Community Services and take place online on Tuesday 27 March 2024. The event was due to cover presentations and Q&A sessions from:

- Kingston Hospital, Hounslow and Richmond Community Health and Your Health Care
- HWK update on our Enter and View of Nutrition on Kingston Hospital Inpatient Wards and Outpatient Areas.

Due to the commencement of the pre-election period, a collective decision was taken to postpone our proposed Hospital and Community Services discussion until after the local elections.

Instead, Healthwatch Kingston delivered a shorter Open Meeting that engaged local people about our community engagement plans for 2024-25. Every year, Healthwatch Kingston invites local people and professional stakeholders to help us prioritise our community engagement plans for the coming year. The two topics we discussed were 0-5 years health and care needs and the social isolation needs of people with a disability.

SLPCC will need to approve the summary report. • HWK will aim to publish our summary report and recommendations after the SWL subgroup in May 2024.
